ROAD REPORT:

Filled potholes on Ferguson Road

Pipe and boxes for Greeley Road were ordered on April 14 and delivered on April 30.

Water line was installed to church camp over Easter weekend. A new cross pipe provided by the township was installed. One load of 2A provided by the township was used to stone the pipe. #8's were spread on Masters Road.

Geer driveway pipe was jetted.

Bids for pipe installation and road repair for Greeley Road were obtained.

Per Chairman Greeley a 7' squash pipe was ordered from Interstate Pipe Supply. Pipe was delivered May 8, 2025.

Per Chairman Greeley Stephenson Equipment came to check hydraulic pressures on the excavator.

Cleaned ditches on Greelev Road. Rolled and stoned with 4 loads of 2A.

Cleaned ditches on Turner Road. Rolled and stoned with 6 loads of 57's. Additional two loads of 57's and millings were taken to help with mud.

 - Motion by Supervisor MacBeth to accept the bid from Lindemuth Excavating Inc. to repair 1500' section of Greeley Road. Second by Chairman Greeley. Vote 3 ayes. Motion carried.
 - Motion by Chairman Greeley to accept the bid from Lindemuth Excavating Inc.to repair 1000' section of Greeley Road. Second by Supervisor MacBeth. Vote 3 ayes. Motion carried.
 - Motion by Supervisor Raybuck to accept the bid from Lindemuth Excavating Inc. to replace the pipe on Greeley Road. Second by Supervisor MacBeth. Vote 3 ayes. Motion carried.
- **5.** Discuss need for additional employee on the Road Crew.
 - Motion by Chairman Greeley to hire new employee for the Road Crew. Second by Supervisor Raybuck.
 Vote 2 ayes. Motion carried.
- 6. Discuss projects for Jackson and Park Roads.
 - Motion by Chairman Greeley to seek bids for reconstruction of road base, geotextile and stone for Jackson Road. Second by Supervisor MacBeth. Vote 3 ayes. Motion carried.
 - Motion by Chairman Greeley to seek bids for reconstruction of road base, geotextile and stone Park Road. Second by Supervisor MacBeth. Vote 3 ayes. Motion carried.

OTHER SUPERVISOR COMMENTS OR CONCERNS:

- 1. Chairman Greeley is meeting with Marc Skarbec, from PennDOT on Wednesday May 14 to discuss Greeley Road Paving Project.
- 2. Chairman Greeley informed the supervisors that the grant from the Conservation District was denied.
