REGULAR MEETING MINUTES

This meeting was held at the Eldred Township Building on September 8, 2025. Chairman Greeley called the Roll Call. Supervisors Gordon Greeley and Laird Raybuck were in attendance. Supervisor MacBeth was unable to attend.

PUBLIC COMMENT PERIOD

A resident asked about back taxes and how things were handled. Supervisors Greeley and Raybuck as well as Tax Collector Lorie Park explained the procedures with delinquent taxes.

MINUTES:

Motion by Supervisor Raybuck to approve the August 11,2025, Regular Meeting Minutes. Second by Chairman Greeley. Vote: 2 ayes. Motion carried.

Motion by Supervisor Raybuck to acknowledge receipt of the Treasurer's Report. Second by Chairman Greeley. Vote: 2 ayes. Motion carried.

Motion by Supervisor Raybuck to approve payment of the August 2025 invoices in the amount of \$131,169.78 Second by Chairman Greeley. Vote: 2 ayes. Motion carried.

Motion by Supervisor Raybuck to approve payment of the August 2025 payroll expenses in the amount of \$15.595.36. Second by Chairman Greeley. Vote: 2 aves. Motion carried.

ROAD REPORT:

Mowing is complete. Need to get ditcher head put on.

Athey'd and broomed Catholic Church Road.

Berms were done on Greeley Road where the curbs are going to be paved.

Put 60 tons of #4's in ditch on Greeley Road.

Installed 3 driveway pipes for Terry Jackson on Jackson Road.

Planning on tearing up and reworking McManigle Road and turning it to dirt and gravel.

Spread dust control on Jackson, Big Dam and Gilbert Roads.

Dug the millings pile up in preparation for the paving project to use as a backer for the new road berm.

Started to repair snowplows.

Cold patching was done on Fisher, Jackson and Oakdale Roads.

A representative from Hawbaker stated that the paving project on Greeley Road would start on Tuesday the 9th. There have been no further updates.

UNFINISHED BUSINESS:

1. At the August 11, 2025, meeting the Supervisors discussed resident concerns regarding the condition of the back portion of the township's yard. Chairman Greeley spoke with the owner of the property and was told that they are working on it. As of this meeting, some changes have been made to the yard. Chairman Greeley and Supervisor Raybuck agreed that no action should be taken at this time, and the situation will continue to be monitored.

NEW BUSINESS:

- **1.** Ann Packett and Patreen Raybuck from the Mt. Tabor Presbyterian Church are requesting a donation from the Township for the Wreaths Across America organization. Motion by Supervisor Raybuck that the township refrain from donating to the Wreaths Across America. Second by Chairman Greeley. Vote: 2 ayes. Motion carried.
- 2. The township received a letter from The Rebecca M Arthurs Memorial Library asking the Supervisors to

consider an annual contribution of \$1,000.00 or more. The township donated \$250.00 in 2015 and 2016 and has not contributed since then. Motion by Supervisor Raybuck that the township refrain from donating to RMA Memorial Library. Second by Chairman Greeley. Vote: 2 ayes. Motion carried.

3. Cindy Manns presented the Supervisors with a Transmittal Memo advising of the 2026 Minimum Municipal Obligation (MMO) for the pension plan with Pennsylvania Municipal Retirement System. The amount of the MMO for 2026 is \$12,083.36 and is based on the estimated 2025 payroll for employees covered by the plan. The MMO is Eldred Township's 2026 bill for the pension plan. Motion by Supervisor Raybuck to approve the 2026 MMO Worksheet. Second by Chairman Greeley. Vote: 2 ayes. Motion carried.

OTHER SUPERVISOR COMMENTS OR CONCERNS:

1. The Supervisors discussed the options to provide a third plow truck. Supervisor Raybuck made a motion to spend up to \$23,800.00 on the purchase of a new plow truck. Second by Chairman Greeley. Vote: 2 ayes. Motion carried.

Supervisor Raybuck made a motion to adjourn at 5:07 PM. The motion was seconded by Chairman Greeley. Vote: 2 ayes. Motion carried and the meeting adjourned.
