A resident expressed concerns about the condition of Jackson Road Kahletown hill and culverts. The Road Foreman and Supervisors discussed upcoming projects with residents.

Motion by Supervisor MacBeth to approve payment of the May 2025 payroll expenses in the amount of \$14,766.30. Second by Supervisor Raybuck. Vote: 3 ayes. Motion carried.

ROAD REPORT:

Greeley Rd culvert installed by Lindemuth Excavating.

Hauled 2A for Lindemuth for culvert.

Greeley Road ditched and rolled.

Greeley Rd cross drain installed by Northey residence by the Twp.

Ordered and received calcium chloride for dust control.

Graded bad spots on Mineweaser, Seigworth, Spring Creek, Miller, Jackson and McCutcheon Roads.

Lindemuth Excavating did both the 1000' and the 1500' sections of Greeley Road. To raise them with geo tex fabric and bank run stone.

The township is still working to finish with 2A.

UNFINISHED BUSINESS:

NEW BUSINESS:

1. The Supervisors, Tax Collector and Secretary discussed measures that can be taken to secure the bank account used for tax purposes. The account will be coded so that no ACH debits or credit are permitted.
