

**Eldred Township Supervisors**  
**Regular Meeting**  
September 9, 2024

This meeting was held at the Eldred Township Building. Chairman Greeley called the meeting to order at 4:30 PM. The meeting was opened with a salute to the flag. Roll Call. Supervisors Gordon Greeley, Laird Raybuck and John MacBeth were in attendance.

**PUBLIC COMMENT PERIOD:**

Several citizens addressed the conditions and maintenance on various township roads. Chairman Greeley discussed upcoming projects for these roads noting that issues with equipment and few employees exist. Chairman Greeley mentioned potential grant money to help cover the cost of paving Greeley Road. Chairman Greeley plans to apply for more grants to help cover costs of future projects. A concerned citizen requested speed limit and watch children signs for Osborne Road.

Motion by Chairman Greeley to appoint Cindy Manns as the Township's Open Records Officer. Second by Supervisor Raybuck. Vote: 3 ayes. Motion carried.

Motion by Chairman Greeley to appoint Cindy Manns as the Township's Floodplain Administrator and reevaluate the appointment if necessary. Second by Supervisor MacBeth. Vote: 3 ayes. Motion carried.

Motion by Chairman Greeley to appoint Cindy Manns as the Township's Municipal Representative for land use and building permits. Second by Supervisor Laird . Vote: 3 ayes. Motion carried.

Chairman Greeley made a motion to approve receipt of the Regular Meeting Minutes for August 12, 2024. The motion was seconded by Supervisor MacBeth. Vote: 3 ayes. Motion carried.

Chairman Greeley made a motion to approve payment of the invoices for August 2024 in the amount of \$16,947.09. The motion was seconded by Supervisor Raybuck. Vote: 3 ayes. Motion carried.

Supervisor Raybuck made a motion to approve payment of payroll expenses for August 2024 in the amount of \$10,464.39. The motion was seconded by Chairman Greeley. Vote: 3 ayes. Motion carried.

**ROAD REPORT:**

1. The crew will be working on ditches on Greeley Road on Thursday. Chairman Greeley will run the grader.

**UNFINISHED BUSINESS:**

1. Chairman Greeley said that the estimate to fix 2001 yellow International was \$6,000.00 - \$8,000.00. Chairman Greeley was able to find someone to come on sight and do the necessary repair for \$600.00 - \$700.00. Chairman Greeley will make the arrangements to get it fixed. The bed is in good shape, only the frame needs to be welded.

**NEW BUSINESS:**

1. Supervisor MacBeth recommended that the Roadmaster should attend regular meetings, and his work schedule could be adjusted to accommodate this change.
2. Supervisor MacBeth recommended a personnel meeting to discuss upcoming road maintenance needs.
