

Eldred Township Supervisors
Regular Meeting
November 11, 2024

This meeting was held at the Eldred Township Building. Chairman Greeley called the meeting to order at 4:30 PM. The meeting was opened with a salute to the flag. Roll Call. Supervisors Gordon Greeley and Laird Raybuck were in attendance.

PUBLIC COMMENT PERIOD:

No public comments.

Motion by Laird Raybuck to approve Regular Meeting Minutes for October 14, 2024. The motion was seconded by Chairman Greeley. Vote: 2 ayes. Motion carried.

Supervisor Raybuck made a motion to acknowledge receipt of the Treasurer's Report. The motion was seconded by Chairman Greeley. Vote: 2 ayes. Motion carried.

Supervisor Raybuck made a motion to approve payment of the invoices for October 2024 in the amount of \$70,076.22. The motion was seconded by Chairman Greeley. Vote: 2 ayes. Motion carried.

Supervisor Raybuck made a motion to approve payment of payroll expenses for October 2024 in the amount of \$9,926.12. The motion was seconded by Supervisor Raybuck. Vote: 3 ayes. Motion carried.

ROADMASTER REPORT:

1. Made new bumpers for 2010 International. Crew also worked on some electrical switch issues.
2. Reset bridge barriers on Mill Run. This was the second time they were moved so dirt was piled in front to hinder removal.
3. Placed cold patch on half of O'Donnell Road.
4. All Mineweaser/Deamers Hill was cold patched where required the worst.
5. Greeley Road culvert on Turn Hole on inlet was filled.
6. Broken mirror on 2008 Ford 550 from unsecured crank handle on farming equipment. The truck was moved as far out of the way as possible, but mirror was damaged. Followed the driver to make contact and take pictures. We are waiting to hear from the other driver about a replacement.
7. Seigworth lane was mowed.
8. Cold patch was applied to Old 36 and part of Beers Road.
9. Leaves were blown off Greeley Road and Warren Road.
