Motion by Supervisor Raybuck to approve the October 13, 2025, Regular Meeting Minutes. Second by Supervisor MacBeth. Vote: 3 ayes. Motion carried.

Motion by Chairman Greeley to approve payment of the October 2025 invoices in the amount of \$30,048.42 Second by Supervisor MacBeth. Vote: 3 ayes. Motion carried.

Motion by Supervisor Raybuck to approve payment of the October 2025 payroll expenses in the amount of \$14,346.99. Second by Supervisor MacBeth. Vote: 3 ayes. Motion carried.

**ROAD REPORT:**

Finished third plow truck and took it to Knapps for inspection and to get the exhaust deleted  
Backhoe cylinder pin was installed. Repairs are complete.  
Replaced bearings on all three plow trucks for salt spreaders  
Working on getting belt spreader fitted to Paul's truck  
Tried smoothing out McManigle Road with 2A in worst spots  
Ripped out homeowner's culvert pipe on Beers Road  
Cleared tree debris on Beers Road  
Ordered low shoulder signs for Greeley Road  
Ordered 400 tons 2RC. 354 tons have been delivered  
Stoned driveways with bad drop offs along Greeley Road  
Applied sealer to McManigle Road Bridge  
New radios were delivered and installed October 15<sup>th</sup> and 16<sup>th</sup>.

**UNFINISHED BUSINESS:**

**NEW BUSINESS:**

1. PennDOT District 10 Municipal Services Supervisor, Steve Vasbinder, has provided the township with information regarding the All-Terrain Vehicle (ATV) Road Designation Engineering and Traffic Study. Supervisors reviewed and discussed this information. No decision was made.

2. After meeting with officials from PennDOT Chairman Greeley received the authority to raise the weight limit on the bridge over Mill Run on McManigle Road from 5 tons to 7 tons. Road Foreman, Ryan Graham, made the necessary changes to the weight limit signs. PennDOT was notified that the changes were made.

3. The township received notice that the 2026 ESTIMATED Liquid Fuels (Act 655) allocation is \$147,489.11. This amount is \$ 768.38 less than the \$148,257.49 that the township received in 2025. The

Turnback Program ESTIMATED allocation should remain unchanged from 2025 in the amount of \$31,840.00.

4. The Jefferson County Solid Waste Authority (JCSWA) is again requesting a \$500.00 annual contribution from the township. Motion by Chairman Greeley to contribute \$500.00 to the JCSWA. Second by Supervisor Raybuck. Vote: 3 ayes. Motion carried.

5. The Jefferson County Area Agency on Aging (JCAAA) is requesting a \$500.00 a donation from the township. No donation will be made.

8. The Liquid Fuels Audit was conducted on November 5<sup>th</sup> and 6<sup>th</sup>, 2025. Results will be forthcoming.

Chairman Greeley made a motion to adjourn at 5:20 PM. The motion was seconded by Supervisor Raybuck. Vote:3 ayes. Motion carried and the meeting adjourned.
